Portable Emissions Measurement System

MAHLE Powertrain has recently expanded its extensive vehicle emissions testing capability at its Northampton, UK headquarters to include Portable Emissions Measurement System (PEMS) testing.

This new service further enhances the vehicle testing services which are available and allows the precise measurement of tailpipe emissions whilst the vehicle is being driven on road.

This testing forms part of the new RDE (real driving emissions) gaseous and particulate number (PN) legislation requirements for EU type approval which is coming into force in September 2017, with the monitoring phase already underway. It will also provide a more accurate measurement of fuel consumption / CO₂ emissions during 'real world' driving conditions. MAHLE Powertrain was the first ISP to be certified by the VCA to perform legislative RDE emissions testing. Enabling full service from development to certification.
